USER MANUAL FOR ISSUE OF FIRM REGISTRATION CERTIFICATE

The following manual will assist the **user** to apply for the Firm Registration:

All the User shall adopt on the following steps to access the official website of 'Sikkim Go Portal with Single Sign on System', to apply Firm Registration.




Figure 1: Sikkim Go Portal with Single Sign on System.

Firstly, open any browser (chrome, internet explorer, Mozilla Firefox etc.) and enter the URL https://sikkim.gov.in as illustrated in Figure 1.

Click on login in bottom as illustrated in the given Figure 1.

- Clicking on the 'Log In', button, a page will appear as shown in the below Figure 2.
- Enter the required field i.e., Email, Password and Captcha to access the User's Dashboard of the SSO in the page.

- > If the user is new, they should select the "Create Account" option to register and create their account.
- After filling up the required details click on the 'Login', button.




Figure 3: User's Dashboard

- Now, User's Dashboard will appear as illustrated in the below figure 3.
- The user can view their submitted applications on the Applied section, as well as their accepted applications on the Approved section, and their rejected applications on the Rejection section as shown in the below figure 3.
- The user can find the list of necessary required documents to apply for a Primitive Tribe Certificate under the Instruction/Guidelines section.
- The Application Updates section is where the user can find notifications and updates for their applications as shown in the below figure 3.

Here are the steps that must be taken in order to apply for the issue of Firm Registration certificate by the user:

- > **Step1:** As you can see in the User's Dashboard, there is an option for a new application. Clicking on that button will reveal the application page as illustrated in Figure 4 below.




Figure 3: User's Dashboard

- The application process consists of three steps. First, the applicant is required to provide their application details. In the second step, the applicant needs to upload the necessary documents. Finally, the applicant is required to pay the application fee and submit their application as illustrate in the Figure 3 below.




Figure 5: User's Application Details

> **Step2:** After completing the application details the user/applicant must post their photo and signature as shown in below figure 5.




Figure 6: User's Application Details

- > **Step3:** After click on "Save & Continue," the next page will open, asking the applicant to upload the documents that are required as shown in below figure 6.
- > Step4: The user must now upload the necessary documents by first choosing the document's name from the drop-down menu, clicking on "Choose File," choosing the correct file, and then click on upload, the file will be uploaded successfully as shown in the below figure 6.

Note: The selected file's name must not contain any special characters or symbols, and its size must not exceed 10 MB.

> **Step5:** After selecting "Save & Continue," the applicant can check their uploaded documents and review them before final submission as shown in the below figure 7.




Figure 6: User's Application Details




Figure 8: User's Confirm Submission

> Step6: After clicking on pay and submit, a pop-up screen will appear asking the Users to confirm their submission as shown in the below figure 8.

➤ **Step7:** If the transaction was successfully completed, the applicant will receive an acknowledgment slip and the application has been submitted as shown in the below figure 7.




Figure 8: Application Acknowledgement Slip




Figure 9: User's Submission Details

➤ Step 8: The applicant can check whether or not their data has been submitted by clicking the "My Application" section. The applicant can view the status of their application as "Submitted" as illustrated in the figure 9.




Figure 10: User's Dashboard

> Step 9: Once the application has been successfully submitted, it will undergo a verification process, once the officer approves the application, the applicant will be notified in the application updates section. The notification will indicate that they need to proceed with the payment of the registration fee, as shown in Figure 10.




Figure 11: User's Dashboard

> **Step 10:** Upon clicking the notification, a new page will be revealed, prompting the applicant to proceed with the registration fee payment, as illustrated in Figure 11 below.




Figure 12: User's Dashboard

> **Step11:** Next, the applicant is required to make the payment by clicking on the "Make Payment" button. Upon doing so, a pop-up confirmation will appear, as illustrated in Figure 12 below.




Figure 13: User's Dashboard

➤ **Step 12:** Once the applicant has successfully made the registration fee payment, they will receive an acknowledgment slip. The application will then be submitted, and this process is represented in Figure 13 below.

The applicant can check whether or not their application has been submitted by clicking the "My Application" section. The applicant can view the status of their application as "Registration Fee Paid" as illustrated in the figure 14 below.




Figure 13: User's Dashboard
